- With respect to the minutes of the November 10 meeting, Victor, David and Judah have committed to forming a special sub-committee of the Board that will review each of the existing committee mandates and terms of reference.
 - Elisheva will circulate these documents to this new sub-committee.

- \$125,000 from the Ottawa Kosher Food Bank account has been deposited into a term deposit at TD.
- Occupancy costs remain down.
- KBI logo and website costs were incurred.
- Only \$3,400 outstanding on membership dues (very low – good news!).

5.1 Committees and Reports Protocol

Rabbi Kenter

1. OVH CKC Update
 - Rabbi Kenter spoke about how Creative Kosher Catering is no longer under the Ottawa Va'ad Hakashrut supervision. External and independent supervision is necessary in order for a kosher catering company to be viable.
 - Helen Zipes asked if KBI could, potentially, bring CKC in to the building with Rabbi Kenter as the mashgiach. Rabbi Kenter responded that KBI would not be crossing that bridge at this time. Other caterers will hopefully be stepping into the “void” that this “parting-of-ways” has created.
2. Streamspot Metrics
 - Rabbi Kenter reported that there have been 145 unique viewers of KBI's virtual services in the past 30 days.
 - Attendance did dip post High Holy Days but tends to increase on Shabbat when some “new” alternative is offered.
3. Membership Update
 - Elisheva prepared and presented a report stating that 530 “units” (families) have renewed out of 601.
 - 20 new units have joined.

- 20 units are taking a year off this year and most of those were families that came to us through the JUMP-start program.
- 4 units have moved away.
- KBI staff continues to reach out to the remaining 36 units.
- These numbers encourage Judah and he mentioned that the budget the Board prepared is tracking very well against the number of units we have retained.

5.2 Work of Board

Judah Silverman

- Judah acknowledged the Board with appreciation for the special meeting the Board attended on November 10, 2020.
- Judah asked that the Chair of each committee submit a report on the month's activities in advance of each monthly Board meeting. This enables a discussion during Board meetings. These committee reports should be submitted to Elisheva before Shabbat on the week prior to the scheduled Board meeting.
- Judah asked the Board to consider how we may engage KBI members with respect to fundraising.
- Rabbi Kenter spoke about the considerable but necessary time the Clergy has put in to contacting and connecting with members during the pandemic.
- Judah said that a committee needs to be struck to spearhead outreach, which needs to be ongoing.
- David Lyman, Donna Strauss and Helen Zipes will head this committee.
