1.0 PRELIMINARY MATTERS

1.6 Life and Legacy Discussion

Micah Garten

Micah shared some highlights of the Life and Legacy initiative in many Ottawa Jewish organizations that was launched on March 1, 2020:

- 310 community members have signed up
- 600 gifts have been promised or made
- There is a correlation between annual giving and signing up for Life and Legacy; as soon as people make a commitment to Life and Legacy, their annual giving (donation) increases.
- KBI is currently in year 3 of a 4-year program that is encouraging and training organizations like ours.
- Life and Legacy must be interwoven into other philanthropic programming so that it becomes part of our culture.
- Stewardship of Legacy donors is essential, to continue to give honour and attention to people who have made pledges. The Jewish community is improving in this, and he encouraged KBI to act more vigorously in recognizing Legacy donors.

Gillian mentioned that the Government Gives Campaign lists KBI as an organization to whom its employees can make donations. Perhaps KBI can remind its government employee members to check the KBI box during the government's annual United Way campaign.

2.2 Quarterly Financial Report

REVENUES:

- Donated revenues are close to where we expected them
- Credit card charges are up, reflecting receipt of more revenue payments
- Hall and kitchen rentals are higher than expected
- Yizkor Book donations were slightly lower than expected
- A Life and Legacy grant was received from the American foundation that is sponsoring this entire initiative: Approximately \$6200.00
- CBSO grants that have been promised should be coming in soon
- Kiddush sponsorships are higher than expected
- Tuition for OTT is higher than expected
- Revenues are understated on this financial statement because some revenues are still coming in, such as Bingo payments and someother grant monies.

EXPENSES:

- Personnel costs are down because we don't yet have a full-time Youth Coordinator and there are also vacancies in office personnel
- \$70,000.00 has been ear-marked for maintenance and repairs
- A discussion at the June Board meeting should take place about increasing membership fees to cover the credit card usage fees
- Re: Programming costs and revenues

3.1 Terms of Reference for Two Committees

Jeff spoke about the **Membership Committee**'s recruitment and retention goals for members. Improving communication with members and potential members is crucial.

A motion was made by Jeff Greenberg and seconded by David Lyman to approve the Terms of Reference as proposed by the Membership Committee.

All were in favour. The motion was carried.

Jeff said that the **Buildings and Lands Committee** continues to meet and it focuses on the items that have been identified. Priorities include repairs that may affect health and safety in the building. Many smaller and mid-size items have been completed. Now, the focus will shift towards items that are "desireable". Some items being considered include:

- Replace main sanctuary curtains
- Replace existing ceiling in the hallway from the side entrance, including lighting
- Replace flooring from side entrance door to playroom and lobby

A motion was made by Jeff Greenberg and seconded by Norm Ferkin to adopt the Terms of Reference as proposed by the Buildings and Lands Committee.
