2.1 Executive Director's Written Statement Respecting the Status of Staff Salaries and Remittances to Government

Rena presented the statement for employee wages to the Board.

We moved to Section 4.4 of the agenda because Adina Libin was unavailable.

4.4 Update on Membership Campaign

R. Gasrshowitz

Rena Reported that 502 full households have renewed their membership which is just over \$750 000 in revenue.

The team is still working on the renewal of 120 households, 20-25 of which are likely to renew.

Norm asked what the cost of an Associate Membership is. KBI charges \$300/per person.

We are very close to what we budgeted for in terms of membership revenue.

Last year at this time, KBI had collected \$815 000 in annual dues.

We moved back to Section 3: Reporting with Discussion and Vote at this juncture of the Board Meeting.

3.0 REPORTING WITH DISCUSSION AND VOTE

3.1 Presentation of Draft Financial Statement

Adina Libin

Adina walked the Board through the Draft Financial Statement:

- The auditor has made no qualifications nor do they have any concerns
- This is considered a clean audit report
- Adina began with the Statement of Operations:
 - Surplus last year of \$1 008 420; deficit this year of \$1 007 618
 - Our investments “took a hit” (like they did world-wide)
 - The investment fund loss is an “on paper” loss and not a realized loss because we have not sold any investments
 - KBI made an increase in it wages to the maintenance team to bring them up to a living wage
- Adina referred to the Special Purpose Fund
 - It includes to OKFB, which shows a loss in that account due to the many, and high needs in the community for food
 - This fund will include OTT in the future
- Jaimee asked if there could be a different line within the statement for Youth Programming. Adina replied that specific Youth Programming costs and revenues could be shared but that this statement is for the whole community.

- Adina reported that KBI's losses were expected and that the Finance and Audit Committee has set goals and made difficult decisions this past year to ensure sustainability
- Rabbi Kenter stated that the Endowment Fund is meant to be accessed with prudence.
- Other pages from the Financial Statement such as the Statement of Financial Position and Statement of Changes in Net Assets were presented
- Judah reiterated that the interest income from the Endowment Fund may be used and only a percentage of it; the capital will not be touched
- Jeremy suggested that the percentage of the interest of the endowment investment that is accessed, needs to be formalized

A motion was made by Adina Libin and seconded by Judah Silverman to approve the 2022-2023 Audited Financial Statements for KBI.

All were in favour. The motion was carried.

Adina thanked Lana, Rena and KBI staff, as well as the Audit and Finance Committee for their hard work on the budget.

3.2 OTT at KBI Progress

Jeremy Rudin

Jeremy reported that the process has continued to move along and that by now the Committee is preparing to launch registration for the OTT on KBI's website and is engaging staff for the coming year.

In addition to its commitments under the Agreement in Principle, OTT has agreed that, prior to the transition of control of the OTT Corporation to KBI, OTT will:

- make best efforts to recover any outstanding tuition payments
- repay the loan that it received from the Government of Canada
- and prepare financial statements for the fiscal year, including an income statement and balance sheet

KBI will treat the accumulated surplus (approximately \$90 000) that is on the OTT balance sheet as a special purpose fund, to be used for the benefit of the school.

KBI will have full control over the operation of the school once the current school year ends, even though KBI does not yet have control of the OTT Corporation. The final date for the formal transition of control is not yet

determined; however, KBI expects the date to be before the new school year begins. This does not impede KBI's ability to operate the school in any way. The only practical implication is that KBI does not control the accumulated surplus until the transition is completed.

Jeremy shared the Terms of Reference for the OTT@KBI Committee.

Jeremy Rudin will be appointed the Chair of the Committee.

Rabbi Kenter shared the progress he has made to launch OTT including who the Interim Director will be as well as consulting that will take place over the summer to prepare for the start of the school year. For example, moving forward, the Tuesday and Thursday programming will differ. Also, OTT will take over JTeen programming.

There will be an Early Bird tuition rate through the end of July.

A motion was made by Jeremy Rudin and seconded by Harland Tanner that KBI establish the OTT@KBI Committee with its set terms of reference and mandate for 5783 (2022-2023) and that Jeremy Rudin be appointed Chair of the Committee.

All were in favour. The motion was carried.

Jeremy thanked David Lyman, Olga Strelchenko and Harland Tanner for their hard work as members of the committee that helped launch OTT@KBI.

4.1 Youth Report

Jaimee reported that the Youth Leadership Council would be taking on the planning of one event per month for Geshar and USY-aged youth under the guidance and support of Cantor Green. Cantor Green will plan one event per month for the younger youth.

There is an upcoming regional event to La Ronde on September 11th.

Cantor Green detailed the wonderful programs that were organized and executed during the month of May.

4.2 Update on Membership Committee and Renewal Jeff Greenberg

Jeff said that within the next few weeks, membership forms or renewal forms would be sent out to members. The Committee will focus on members who have not renewed in the last year or two and endeavour to target this demographic in an engaging and meaningful way.

4.3 Other Business Raised By a Director

Rabbi Kenter spoke about the “rejigging” of Clergy responsibilities. OTT is set to launch. It is expected that the Women’s Torah Study every Wednesday will continue to run. A few individuals have applied for the position and interviews have begun. Summer programming is in place and the team is focussed on making sure that planning is underway for September.
